Please read this carefully, this is a Release of Liability, Indemnification Agreement, & Waiver of Legal Rights

1. I acknowledge that participating in a skiing, snowboarding and skateboarding competition or training in connection with such event (collectively, the "Event") involves inherent danger and other risks any of which may result in serious injury or death. These dangers and risks include, but are not limited to: snow and icy conditions as they exist or may change, boarding and riding the lifts, collisions with natural objects or man-made structures and their components; variations in steepness or terrain, whether natural or as a result of slope design, encounters and/or collisions with snowmaking or grooming operations, and collisions with other skiers, snowboarders or observers. I voluntarily agree to expressly assume all risks associated with my or the Minor's participation in or training for the Event without limitation. I understand that I have the opportunity to inspect the competition area prior to my or the Minor's training or participating in the Event. I understand that inverted aerials are not recommended.

2. In consideration for Cannonsburg Ski Area allowing me or the Minor to participate in the Event, I agree to defend, indemnify, release and hold harmless Cannonsburg Ski Area & 6800 Cannonsburg, LLC, its affiliated companies, their respective agents, officers, directors, owners, contractors and employees (collectively, the "Released Parties") from any and all claims arising from or related to my or the Minor's participation in the Event including, but not limited to, claims of negligence including negligence of the Released Parties and those brought by the Minor (if applicable), breach of contract, improper course design, subrogation and/or derivative claims brought by any third party or insurer and breach of statutory duty. I further agree to indemnify the Released Parties for any and all damages related to any and all claims, including attorney fees and costs without limitation.

3. I authorize the Released Parties to render first aid and to call for medical care for me or the Minor if, in their opinion, such care is needed during my or the Minor's participation in the Event. I agree to pay all costs associated with the care and related transportation.

This release of liability supersedes any other agreements or representations by or between the parties and shall be governed by the laws of the State of Michigan with exclusive jurisdiction of the courts located within Kent County, Michigan. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I understand that this agreement shall be binding upon my heirs, executors, administrators and assigns.

5. I consent to the use by the Released Parties of any pictures (video and/or photo) for commercial purposes or otherwise, of me or the Minor in connection with Cannonsburg Ski Area without restriction as to frequency, duration or medium.
